8/07/09: Gov. Paterson today signed Executive Order No. 25, to eliminate unnecessary regulatory requirements on businesses and local governments. The Executive Order will spur economic growth by removing needless and excessive rules and paperwork requirements finally the streamlined regulations will better protect the health, safety and welfare of all New Yorkers

8/10/09: Gov. Paterson today announced that the New York State Energy Planning Board has prepared a comprehensive draft State Energy Plan, the first step in redefining how the State approaches and satisfies its energy needs. The draft Plan identifies strategies and provides recommendations that once implemented will make energy more reliable, secure and affordable for New Yorkers.

8/14/09: Gov. Paterson today announced the appointments of James J. Wrynn to serve as New York State Superintendent of Insurance and Wendy Saunders to serve as Deputy Secretary for Health, Medicaid and Oversight. The Governor also announced the appointments of Kristin Proud to serve as Deputy Secretary for Human Services, Technology and Operations and Senior Advisor to the Office of Taxpayer Accountability, and Mark Leinung to serve as Deputy Director for State Operations.

8/25/09: Gov. Paterson today announced the kick-off of the New York State Smart Grid Consortium to foster the development and deployment of new technology aimed at reducing the cost of electricity while increasing reliability. The Consortium will be comprised of leaders from government, utility companies and universities, as well as consumers, and will develop a strategic vision on how best to deploy secure, efficient and reliable smart grid technologies in New York.

8/27/09: The New York State Chief Information Officer and Office for Technology (CIO/OFT) announced enhancements to the CIO Council Charter to improve the effectiveness of the CIO Council and ensure alignment with recently released New York State IT Enterprise Strategy.
