3/3/10: In one of her first acts as Acting Commissioner of Labor for New York State, Colleen C. Gardner today directed the Department of Labor staff to take an "all hands on deck" approach to help the Center for Economic Growth (CEG) and local partners create a sustainable workforce in the Capital Region. This workforce will be needed to support new jobs at GLOBALFOUNDRIES, General Electric, as well as 100 manufacturing and technology companies across the region.

3/5/10: The New York State Chief Information Officer and Office for Technology (CIO/OFT) held seven, kick-off meetings with state agency Chief Information Officers to formally launch the work of the IT Strategic Clusters introduced in the New York State Enterprise Information Technology Strategic Plan. The IT Strategic Clusters will focus agencies to deliver cost-efficient and integrated IT services by eliminating unnecessary and costly duplication of IT investments.

03/12/10: Governor David A. Paterson today announced the appointments of Mary B. Kavaney to serve as Deputy Secretary for Public Safety and Peter M. Iwanowicz to serve as Deputy Secretary for the Environment. The Governor also announced the appointment of Sean M. Byrne to serve as Acting Commissioner of the Division of Criminal Justice Services (DCJS), and welcomed Deputy Superintendent John P. Melville as Acting Superintendent of the New York State Police.

3/19/10: Governor David A. Paterson today announced \$34.7 million in State funding to support investment in biomedical research and the New Economy through support for stem cell research. The awards to 49 researchers at 16 institutions across New York State were approved March 4 at a meeting of the Funding Committee of the Empire State Stem Cell Board in New York City.
